

## **OFFICIAL RULES FOR THE PRO•LINE “PROLINE 30 FANTASY” PROMOTION FROM THE ATLANTIC LOTTERY CORPORATION (ALC)**

The PRO•LINE “PROLINE 30 FANTASY” promotion provides all prolinestadium.com members (not available for purchase at retail locations) an opportunity to receive up to \$30 in free-play tokens from 06:00:00 Atlantic Standard Time (AST) on September 1, 2024, to 23:59:59 AST on September 30, 2024 (“Promotion Period”).

To earn a \$5 token, a single wager equal to or greater than \$10 must be placed on FANTASY during the Promotion Period. Participants can earn up to six (6) \$5 tokens during the Promotion Period. A maximum of six (6) \$5 tokens (total of \$30) can be earned during the Promotion Period. Tokens can be used only on 2+ event parlays on PRO•LINE, STADIUM•BETS, or FANTASY and expire on October 31, 2024.

**\*Each \$5 token can be used only on PRO•LINE, STADIUM•BETS, or FANTASY which involves a 2+ event parlay at prolinestadium.com only (cannot be used at retailer locations). Tokens earned must be used by October 31, 2024, at 23:59:59. Token amount will be deducted from winnings.**

### **Promotion Period:**

The offer begins at 06:00:00 Atlantic Standard Time (AST) on September 1, 2024 to 23:59:59 AST on September 30, 2024.

### **HOW TO PARTICIPATE:**

To participate in this promotion:

1. Spend an amount of \$10 or more on a FANTASY at prolinestadium.com during the Promotion Period and receive a \$5 token (maximum of six (6) tokens during the Promotion Period) that can be used on 2+ event parlays on PRO•LINE, STADIUM•BETS, or FANTASY.
2. This promotion can be used up to six (6) times, in accordance with the Promotional Period, to earn a total of six (6) \$5 tokens (maximum of \$30). Note: A maximum of one (1) \$5 free-play token will be awarded for each single eligible FANTASY wager totalling \$10 or more during one (1) transaction, so that a single wager on one (1) ticket of, for example, \$20 or \$30 will generate one (1) \$5 free-play token.
3. To participate in the promotion: participants must be 19+; must be a resident of Atlantic Canada; and must have an active and funded alc.ca online account.
4. The offer will run from 06:00:00 Atlantic Standard Time (AST) on September 1, 2024, and closes at 23:59:59 AST on September 30, 2024.

### **PROMOTION REWARDS:**

1. Eligible participants will receive up to a maximum of six (6) \$5 free-play tokens for eligible wagers placed on FANTASY during the Promotion Period.
2. The \$5 free-play tokens will be automatically added to accounts that have made qualifying wagers.
3. Tokens earned can only be used on 2+ event parlays on PRO•LINE, STADIUM•BETS, or FANTASY.
4. Only one (1) token may be used on a single game. A single game includes the sum of all betting markets for that game. For example, you cannot use a token on the moneyline, and then use a second token on the same moneyline, the Spread, Total, H2H (head-to-head) or Winning Margins markets for the same game.
5. Eligible participants must use their \$5 free-play token by October 31, 2024 at 23:59:59 AST (token has no cash value otherwise).

6. There is no cash option for this offer. Token(s) hold no cash value and cannot be used towards earning another token(s).
7. Token amount will be deducted from winnings.
8. Tokens are non-withdrawable.

10. Participants must have an active alc.ca account in order to claim their \$5 free-play token(s).

Please note: Any individual who has falsified their registration information will be ineligible to receive their \$5 token(s).

### **DELIVERY OF PRIZES**

The \$5 free-play token(s) will be automatically added to accounts that have made qualifying wagers. These can be found under "Free Bet Tokens" on the Check-Out page when placing your eligible wager.
