

OFFICIAL PROMOTION RULES AND TERMS AND CONDITIONS

for Atlantic Lottery Corporation's (ALC)

"VIDEO LOTTERY FORT KNOX" PROMOTION

SEPTEMBER 9, 2024 – OCTOBER 20, 2024

PROMOTION PERIOD

The "VIDEO LOTTERY FORT KNOX" promotion begins September 9, 2024 at 10:00:00 AM Atlantic Time (or as soon as the Video Lottery terminals are available) and ends October 20, 2024 at 11:59:59 PM Atlantic Time ("Promotion Period"). The promotion is <u>available for residents of New Brunswick and Newfoundland and Labrador only who are nineteen (19) years of age or older.</u>

Weekly draws will occur according to the below Figure 1 and will consist of weekly escalating cash draws. Players with qualifying ballots will automatically earn one (1) entry in the weekly draw occurring in that same week the eligible product was entered. Players will also earn one (1) grand prize entry for each eligible product entered.

Weekly promotion periods will open on the dates indicated in the below Figure 1 and close on the dates indicated at 11:59:59 PM AT. The contest will close on October 20, 2024, at 11:59:59 PM AT.

HOW TO PARTICIPATE

Participation in the VIDEO LOTTERY FORT KNOX PROMOTION is via ballot entry. To receive a ballot entry, a player must complete a bonus round of a Fort Knox eligible game, being either "Scarab" or "The Wild Life Extreme" (see Qualifying Games in the table below).

NOTE: Fort Knox enabled games can be identified on the Video Lottery terminal game chooser screen. These games (Scarab and The Wild Life Extreme) will also be indicated by the inclusion of the Atlantic Lottery logo over the corner of the game icon.

Classification: Internal. This information is considered normal or routine business information. Any employee within Atlantic Lottery may view the information. Discretion should be used when sharing the information with third parties and stakeholders.

Upon receipt of the ballot, the player must then log into their alc.ca account via 2chance.alc.ca/videolottery and either scan the VLT (Video Lottery Terminal) ballot barcode on a mobile device or manually enter the unique VLT ballot number. For each VLT ballot entered, the player's account will earn an entry into the corresponding weekly draw (see Figure 1) as well as the grand prize draw.

Players can earn a maximum of five (5) entries per day into the weekly draws and five (5) entries per day into the grand prize draw. Players are eligible to win any weekly cash draw entered plus the grand prize draw. Weekly cash draw entries do not carry over week to week. Players will continue to earn their regular Video Lottery spins for each eligible ballot entered.

GRAND PRIZE DRAW

There will be one random grand prize draw at the end of the VIDEO LOTTERY FORT KNOX PROMOTION. The Grand Prize draw will take place October 24, 2024 (or as soon as possible thereafter).

Draws & Prizes

- 1. Players are eligible to win any weekly cash draw entered plus the grand prize draw.
- 2. Weekly cash draw entries do not carry over week to week.
- 3. There will be one (1) Grand Prize draw at the end of the promotion (October 24, 2024, or as soon as possible thereafter).
- 4. The odds of winning a weekly cash draw will depend upon the total number of eligible entries received during the Weekly Promotion Period. The odds of winning the Grand Prize will depend upon the total number of eligible entries received during the Promotion Period.
- 5. All draws adhere to the draw procedures established for the draw by ALC.

DELIVERY OF PRIZING

ALC will attempt to contact the potential winner within one (1) business day after the potential winner has been drawn (or as soon as possible thereafter). Potential winners will be notified using the contact information provided in the alc.ca account. If ALC is not able to contact the potential winner within seven (7) days after initial attempt, ALC shall have the right to disqualify the potential winner; the entry drawn immediately after the disqualified entry will be eligible to win the prize that otherwise would have been awarded for the previously selected entry. This process will continue until ALC is able to contact a potential winner as referred to in this section. ALC shall be fully and completely released and discharged from any liability or responsibility in this regard.

Government issued photo identification must be provided for proof of identification and age in person or via scanner or fax machine within seventy-two (72) hours of being contacted; failure to do this will result in the winner waiving his/her right to the prize. If the winner is under the age of nineteen (19), they will be disqualified and an alternate winner for the same prize will be drawn.

Prize package is non-transferable.

'Immediate Family' means the spouse, sibling, parent, and/or child of an employee referred to above who resides with that employee.

NOTE: Any individual who has falsified their registration information will be ineligible to receive their prize upon winning.

NO PURCHASE NECESSARY.

No purchase is necessary to enter. Entrants can obtain a no purchase online code ("No Purchase Code"), which can be entered into alc.ca to earn one (1) entry in the Video Lottery Fort Knox Promotion. No Purchase Code Requests must be received by ALC no later than October 20, 2024.
