## PROMOTIONAL OFFER:

The Contest Period starts on September 9th, 2024, 10:00 AM AT (or as soon as the machines are available) and ends on February 28, 2025, at 11:59:59 PM AT. The contest is open to residents of New Brunswick, Prince Edward Island and Newfoundland and Labrador who are 19 years of age or older.

### How to enter:

To enter by ballot, an entrant must play a qualifying game (specified below), complete the bonus and either scan the VLT (Video Lottery Terminal) ballot barcode on a mobile device or manually enter the unique VLT ballot number into the Video Lottery site. Participants will be limited to five (5) ballot entries per day. For each VLT ballot entered at 2Chance.alc.ca/videolottery, earn five (5) contest entries and earn one (1) spin on 1 of 3 online games on 2Chance.alc.ca/videolottery. You must play the online game to earn additional entries into this Contest or to win promo cash or gift cards. Entries will be awarded as per the table below and ballot generation will end on February 28, 2025, 11:59:59PM AT for NB/NL/PE ONLY.

## **QUALIFYING GAMES**

Qualifying games will be visible on the video lottery terminals (VLT's) and will have an ALC logo attached to the game icon. Any VLT's without the ALC logo will have the logo shortly after the contest period begins. Any player that receives a ballot during play must follow the directions outlined on the ballot.

Participating games at launch include Jungle Wild, Swinging Bells, Egyptian 7's, Ravens Riches, Bonus 7s Wild Explosion, Monopoly Jackpot Station, Scarab & The Wild Life Extreme with Fort Knox. ALC has the right to launch new participating games or remove any games from participating at any point during the contest.

## NO PURCHASE ENTRY

No purchase is necessary to enter. Entrants can obtain a no purchase online code ("No Purchase Code"), which can be entered into alc.ca to earn one (1) spin in this Contest. ## **ODDS OF WINNING**

The odds of winning a monthly prize will depend upon the total number of eligible entries received for that monthly draw. Entries for each monthly draw are entered for that monthly draw only and are not entered into subsequent monthly draws. ## **DELIVERY OF PRIZES**

ALC will attempt to contact the potential winner(s) within one (1) business day after the monthly draw (or as soon as possible thereafter). Potential winners will be notified using the contact information

provided in the alc.ca account. ## **DELIVERY OF EGIFT CARD PRIZES**

Upon winning an instant win eGift Gift card prize on the Video Lottery spin reel, participants must click on the prize claim link to access and complete a prize claim form. Participants are responsible for ensuring the accuracy of their account information on alc.ca.

Eligible winners will also see a notification on their 2Chance Video Lottery contest page prompting them to complete their prize claim form. Participants must be signed into the contest page to view this notification.

Eligible eGift Card winners have until March 1st, 2025, at 11:59:59 PM AST to complete and correctly answer, unaided, a mathematical skill-testing question and submit the prize claim form within the time frame indicated. Failure to answer the skill-testing question correctly or submit the form within this timeframe will result in disgualification and the prize will be forfeited.
